In recognition that every day needs to be “World Oceans Day” – and indeed it is at the World Ocean Council – the WOC is proud to release [“Ocean Governance and the Private Sector”, a WOC ocean review and foresight document](#) based on longstanding, continuing WOC work with and for the global ocean business community on Ocean Governance.
